NAAS AGENCY

Inspections of Reserves and meetings with the Indians of the Naas Agency occupied the Commission from the 25th September to the 10th October, 1915, Mr. Agent Perry being under examination from the 16th to the 29th December, of the same year.

The Commission found in existence, as defined by the Official Schedule, 63 Reserves allotted to the several tribes and bands of the Naas, these having an aggregate area of 62,854.91 acres, giving 34.94 acres per capita for the Agency Indian population of seventeen hundred and ninety-nine. Investigation disclosed, however, that of this aggregate reserves area a very considerable portion was made up of lands (chiefly in the Tsimpsean Peninsula) utterly useless for Indian or other purposes, and in reality a detriment to the Indians, in giving a fictitious appearance to the extent and value of their holdings.

During their visit to the home of the ancient Nishga nation, the Commissioners were distinctly impressed by the qualities of intelligence, progressiveness, industry and self-reliance displayed by these Indians, and by their requirement of other lands suitable for profitable use. This requirement the Commission has endeavoured to meet by the cutting off of useless allotted lands and the allowance, where available, of other lands applied for by the Indians the potentialities of which render them of greater value to the Indians than the lands so cut off.


The total area of Agency reductions is 11,909.19 acres—principally barren back-lands of the Tsimpsean Peninsula Reserve No. 2—and that of the 130 new Reserves provided for 5,671.00 acres, giving a new total for the Agency of 190 Reserves, with aggregate area of 56,616.72 acres, or a per capita of 31.47 acres for the Agency.

THE ROYAL COMMISSION ON INDIAN AFFAIRS FOR THE PROVINCE OF BRITISH COLUMBIA, 1916

MINUTES OF DECISION

In virtue of powers and instructions from the Governments of the Dominion of Canada and the Province of British Columbia contained in Commissions issued under the Great Seal of Canada respectively on the 23rd day of April, in the year of Our Lord one thousand nine hundred and thirteen, and the 7th day of April, in the year of Our Lord one thousand nine hundred and fourteen, to us directed, authorizing and empowering us as a Commission to fix, determine and establish the number, extent and locality of the Reserves to be set aside, allowed, established and constituted for the use and benefit of the Indians of the Province of British Columbia, we, the undersigned, having in each case made due enquiry into all matters affecting the requirements of the said Indians, do hereby declare the following to be the Reserves for the undermentioned Indian Tribes respectively, the date of our decision being in each case stated.

FISHING RIGHTS OF INDIANS IN B. C.

MINUTE and RESOLUTION of the 6th June, 1916:

"Whereas former Indian Reserves Commissioners, acting under joint Governmental Agreements, allotted defined Fishery Rights to certain Tribes or Bands of Indians in British Columbia;

"Whereas this Commission has been unable to obtain any advice from the law officers of the Crown in right of the Dominion of Canada as to the authority of the said former Commissioners to allot such Fishery Rights;

"AND WHEREAS this Commission desires that any right or title which Indians may have to such allotted Fisheries may not be adversely affected by inaction on its part;

"Be IT RESOLVED: That, to the extent to which the allotting Commissioners had authority to allot such Fishery Rights, this Commission, insofar as the power may lie in it so to do, CONFIRMS the said allotted Fishery Rights as set forth in the Schedule hereto appended:

SCHEDULE

Naas Agency

Naas River Tribe: Minute of Decision of October 20th, 1881, constituting Tsimmanweenclist Reserve No. 2: . . . "The exclusive right of fishing in the Naas for a distance of Two (2) miles upstream from Tsimmanweenclist Reserve No. 2, is assigned to the Indians."

Minute of Decision of October 20th, 1881, constituting Seaks Reserve No. 3: . . . "The exclusive right of fishing in the Seaks River for a distance of One (1) mile from its mouth, is allotted to the Indians."

Minute of Decision of October 20th, 1881, constituting Andegulay Reserve No. 8: . . . "The exclusive right of fishing on the left bank of the Naas commencing at the mouth of Andegulay Slough and extending upstream one-half ($\frac{1}{2}$) mile, also the fisheries in Andegulay Slough for one-half ($\frac{1}{2}$) mile from its mouth are reserved."

Minute of Decision of October 20th, 1881, constituting Lachkaltsap or Grenville Reserve No. 9: . . "The old established fisheries on the Naas River within the limits of this Reserve (No. 9), as also the right to fish in the various sloughs running through it, are reserved for the use of the Indians."

Minute of Decision of October 20th, 1881, constituting Red Cliff Reserve No. 13: . . . "The exclusive right of fishing in the Nanook River for a distance of a quarter of a mile from its mouth is assigned to the Indians."

Minute of Decision of September 8th, 1888, constituting Talahaat Reserve No. 16: . . . "The exclusive right of salmon fishing in the Kin-na-max River the entire length of Talahaat Reserve No. 16, a distance of about one-half (½) mile."

Minute of Decision of October 20th, 1881, constituting Kitladamax Reserve No 1 (A): . . . "The exclusive right of fishing in the Naas River the entire length of Kit-lac-da-max Reserve No. 1 and also in Che-ma-nuc Creek, is allotted to these Indians."

Tsimpsean Tribe: Minute of Decision of October 29th, 1881, constituting Cloyah Reserve No. 5: . . . "The exclusive right of fishing in Cloyah River for a distance of One and one-half (1½) miles from its mouth, is reserved."

Minute of Decision of September 13th, 1882, constituting Toon Reserve No. 15: . . . "The right of fishing in the Toon River for a distance of Two (2) miles upstream from the head of tidal waters, is reserved for the use of the Indians."




NEW WESTMINSTER AGENCY

Comparatively little change has been made by the Commission in the matter of Reserves of the New Westminster Agency, in which tours of visitation were made for inspections of Indian lands and meetings with the occupants thereof during the field seasons of 1913, 1915 and 1916; Mr. Agent Byrne also being examined at length as to Indian affairs of his district, from the 25th January to the 16th February and again on the 7th March, 1916.


The Commission at its organization found allotted for the Indians of the New Westminster Agency 157 Reserves, of an aggregate area of 42,310.99 acres, giving a per capita allowance of 16.45 acres for the Agency. There have been sold and surrendered by the Indians for railway and other public purposes, six Reserves in their entirety. The Commission has cut off one Reserve, in the City of New Westminster, originally established to meet camping requirements, no longer existent, of all Coast tribes, in common; and has reduced one other in more legitimate proportion to the Indian utilization and need, the total area of reduction for the Agency being 152.48 acres. At the same time there have been created to meet determined reasonable requirements of the Indians 18 new Reserves, of 1,168.45 acres in all—giving a net added area for the Agency of 1,015.93 acres, and a new total (including 40,923.37 acres in confirmed Reserves) of 41,939.30 acres, or 16.30 acres per capita.



THE ROYAL COMMISSION ON INDIAN AFFAIRS FOR THE PROVINCE OF BRITISH COLUMBIA, 1916

MINUTES OF DECISION

In virtue of powers and instructions from the Governments of the Dominion of Canada and the Province of British Columbia contained in Commissions issued under the Great Seal of Canada respectively on the 23rd day of April, in the year of Our Lord one thousand nine hundred and thirteen, and the 7th day of April, in the year of Our Lord one thousand nine hundred and fourteen, to us directed, authorizing and empowering us as a Commission to fix, determine and establish the number, extent and locality of the Reserves to be set aside, allowed, established and constituted for the use and benefit of the Indians of the Province of British Columbia, we, the undersigned, having in each case made due enquiry into all matters affecting the requirements of the said Indians, do hereby declare the following to be the Reserves for the undermentioned Indian Tribes respectively, the date of our decision being in each case stated.

Dated at Victoria, British Columbia, this 30th day of June, in the year of Our Lord one thousand nine hundred and sixteen.

FISHING RIGHTS OF INDIANS IN B. C.

MINUTE and RESOLUTION of the 6th June, 1916:

"Whereas former Indian Reserves Commissioners, acting under joint Governmental Agreements, allotted defined Fishery Rights to certain Tribes or Bands of Indians in British Columbia;

"Whereas this Commission has been unable to obtain any advice from the law officers of the Crown in right of the Dominion of Canada as to the authority of the said former Commissioners to allot such Fishery Rights;

"AND WHEREAS this Commission desires that any right or title which Indians may have to such allotted Fisheries may not be adversely affected by inaction on its part,

"BE IT RESOLVED: That, to the extent to which the allotting Commissioners had authority to allot such Fishery Rights, this Commission, insofar as the power may lie in it so to do, confirms the said allotted Fishery Rights as set forth in the Schedule hereto appended:

Sumass Tribe, Lakahahmen Band: Minute of Decision of June 26th, 1879, constituting Lakahahmen Reserve No. 11: . . "The Indians are to have the right of fishing at the little creek near Mr. Bale's where they get large salmon in the fall of the year and the Surveyor may shew this piece on his plan."



OKANAGAN AGENCY


On the 2nd October, 1913, field work in the Okanagan Agency was inaugurated, visitations of Reserves and meetings with the Indians continuing until the 14th of that month, and Mr. Agent Brown being examined at Victoria as to conditions in this Agency, on the 11th November and following days.

The forty-four recognized Reserves of the Okanagan Agency as described in the Official Schedule of 1913 contained an aggregate area of 146,427.66 acres, or 184.18 acres per capita, these Indians being chiefly engaged in mixed farming or cattle raising and their lands being situate in the semi-arid belt, where, as a rule, irrigation on a large scale is pre-requisite to success in the utilization of the land.

Summarizing the work of the Commission in this Agency, it is to be noted that 34 Reserves have been confirmed in whole or in part, with an area of 127,391.41 acres. The areas of reduction and of the nine Reserves cut off as not necessary to the Indians, total 18,536.80 acres; while one new Reserve adjudged to be fairly required, will contain approximately 2,600.00 acres, making 15,936.80 acres the net area of reductions by the Commission, and 129,991.41 acres the new aggregate area of Reserves for the Agency, a per capita of one hundred and sixty-three acres resulting.

THE ROYAL COMMISSION ON INDIAN AFFAIRS FOR THE PROVINCE OF BRITISH COLUMBIA, 1916

MINUTES OF DECISION

WATER RIGHTS OF INDIANS IN B. C.

MINUTE and RESOLUTION of the 15th June, 1916:

"Whereas former Indian Reserves Commissioners, acting under joint Governmental Agreements, allotted defined Water Rights to certain Tribes or Bands of Indians in British Columbia;

"Whereas this Commission desires that any right or title which Indians may have to such allotted Water Rights may not be adversely affected by inaction on its part,

"BE IT RESOLVED: That, to the extent to which the allotting Commissioners had authority to allot such Water Rights, this Commission, insofar as the power may lie in it so to do, CONFIRMS the said allotted Water Rights as set forth in the Schedule hereto appended:

SCHEDULE

Okanagan Agency

Okanagan Tribe: Minute of Decision of October 19th, 1888, constituting Tsin-sti-kep-tum Reserve No. 9: . . . "All water from a creek flowing into Okanagan Lake, near the western boundary of the Reserve, is assigned to the use of the Indians."

Minute of Decision of October 19th, 1888, constituting Tsin-sti-kep-tum Reserve No. 10: . . . "25 inches of water from the creek flowing into Okanagan Lake, near the northern boundary of the Reserve, is allotted to the use of the Indians."

Upper Similkameen Tribe: Minute of Decision of October 26th, 1888, constituting Three Creeks or Chu-chu-way-ha Reserve: . . . "One hundred (100) inches of the water of 20 Mile Creek and Fifty (50) inches each from the two creeks South of the village are assigned to the use of the Indians.

Similkameen Tribe: Minute of Decision of October 30th, 1888, constituting Narcisse's Farm Reserve No. 4: . . . "Ten (10) inches of the water of the small creek flowing from the West through the centre of this Reserve is assigned to the use of the Indians."

Minute of Decision of October 30th, 1888, constituting Joe Nahumcheen's Reserve No. 5: . . . "Ten (10) inches of water from a small creek flowing through this Reserve is allotted to the use of the Indians."


Minute of Decision of October 30th, 1888, constituting Blind Creek Reserve No. 6: . . "The unappropriated water of Blind and Causton Creeks is assigned to the use of the Indians."



QUEEN CHARLOTTE AGENCY

Meetings of the Commission with the Indians of the Queen Charlotte Agency and inspections of their principal Reserves, together with the examination of Mr. Agent Deasy, occupied the period of September 9th to 15th, 1913, the Commission being very favourably impressed by the evidences of substantial and intelligently directed progress presented in the more recent history of the Haidahs.

These Indians at the time of the Commission's appointment had, with a total population of 597, twenty-five Reserves in all allotted for them, of an aggregate acreage of 3484.5, or 5.83 acres per capita for the Agency. The principal occupation of the Haidah (Queen Charlotte Agency) people being fishing, for the canneries and for food supply, the majority of their established Reserves are fishing stations of small area, which, however, they have manifested a desire to cultivate insofar as the character of the soil and opportunities generally permit.


The concentration of the mass of the Indian population of the Agency in the two Reserves of Massett and Skidegate is explained in Evidence as caused by the desire of the Indians to obtain facilities of education and religious vinstruction, and to their having been brought in to the tribal centres in that connection by those in charge of their affairs.

While the representations of the Queen Charlotte Agency Indians for more adequate land allotments were hampered by their identification with the movement for recognition of Aboriginal Title and their fear that applications for additional Reserves might prejudice action in that connection (for which reason the Skidegates declined to discuss their land requirements with the Commission), the Commission did not permit this fact to militate against fair consideration of what investigation elsewhere shewed to be necessary and reasonable requirements of the Tribes.

These were effectively presented by Mr. Agent Deasy, who emphasized the demonstrated desire of the Indians to enlarge their cultivated areas and strongly urged the allowance of new Reserves for which applications had been filed by the Department of Indian Affairs prior to the constitution of the Commission. In regard to these applications it is to be noted that in all save three of thirteen instances, alienation of the lands applied for antedated the official applications therefor, these lands being, when such applications came before the Commission for action thereupon, beyond the disposing power of the Commission.

The Commission favourably considered applications for such lands as were found to be available for Indian Reserve purposes, and the tabulated results of the work for the Queen Charlotte Agency shew seven additional Reserves allowed, aggregating 360.10 acres, which, upon approval, will advance the per capita for the Agency to 6.44 acres. This per capita acreage, it may be remarked, is very low, a circumstance attributable largely to the facts that these Indians are


primarily fishermen and local conditions do not lend themselves favourably to extensive farming operations. In view of the displayed progressiveness of the Haidah people and the rapidity to be noted in their evolution toward the goal of complete citizenship the Commission is of the opinion that encouragement and assistance should where possible be given them in their practical efforts to develop their holdings and improve their conditions, and with respect to particular lands required and long used and occupied by them and found unavailable for constitution as Reserves, by reason of their alienation, the Commission has seen fit to recommend to the Dominion Government the acquirement of the same by purchase, for Additional Reserve purposes.

THE ROYAL COMMISSION ON INDIAN AFFAIRS FOR THE PROVINCE OF BRITISH COLUMBIA, 1916

MINUTES OF DECISION

In virtue of powers and instructions from the Governments of the Dominion of Canada and the Province of British Columbia contained in Commissions issued under the Great Seal of Canada respectively on the 23rd day of April, in the year of Our Lord one thousand nine hundred and thirteen. and the 7th day of April, in the year of Our Lord one thousand nine hundred and fourteen, to us directed, authorizing and empowering us as a Commission to fix, determine and establish the number, extent and locality of the Reserves to be set aside, allowed, established and constituted for the use and benefit of the Indians of the Province of British Columbia, we, the undersigned, having in each case made due enquiry into all matters affecting the requirements of the said Indians, do hereby declare the following to be the Reserves for the undermentioned Indian Tribes respectively, the date of our decision being in each case stated.

Queen Charlotte Agency—Massett Tribe

ORDERED: That all the Reserves belonging to the Massett Tribe, as set out on page 107 in the Official Schedule of Indian Reserves, 1913, and numbered from 1 to 16, both inclusive, BE CONFIRMED as now fixed and determined and shewn on the Official Plans of Survey.

to the Crown in right of the Province of British Columbia, the administration of coal, petroleum and natural gas therein.

FISHING RIGHTS OF INDIANS IN B. C.

MINUTE and RESOLUTION of the 6th June, 1916:

"Whereas former Indian Reserves Commissioners, acting under joint Governmental Agreements, allotted defined Fishery Rights to certain Tribes or Bands of Indians in British Columbia;

"Whereas this Commission has been unable to obtain any advice from the law officers of the Crown in right of the Dominion of Canada as to the authority of the said former Commissioners to allot such Fishery Rights;

"AND WHEREAS this Commission desires that any right or title which Indians may have to such allotted fisheries may not be adversely affected by inaction on its part—

"BE IT RESOLVED: That, to the extent to which the allotting Commissioners had authority to allot such Fishery Rights, this Commission, insofar as the power may lie in it so to do, CONFIRMS the said allotted Fishery Rights as set forth in the Schedule hereto appended:

SCHEDULE

Queen Charlotte Agency

Masset Tribe: Minute of Decision of July 13th, 1882, constituting Lanas Reserve No. 5: . . "The right of fishing in the Yakoun River for a distance of One (1) mile upstream from the southeastern corner post of the Reserve (No. 4) is allotted to the Indians."

Minute of Decision of July 13th, 1882, constituting Jalun Reserve No. 14: . . . "The right to fish in the Jalun River for a distance of One (1) Mile above tidal water is reserved for the use of the Indians."

Skidegate Tribe: Minute of Decision of July 28th, 1882, constituting Deena Reserve No. 3: . . . "The right to fish in the Deena River for a distance of One (1) mile above tidal water is assigned to these Indians."

Minute of Decision of July 28th, 1882, constituting Kaste Reserve No. 6: . . "The right to fish in the Kaste River is assigned to the Indians for a distance of One (1) mile above tidal water."
